

The electronic logging device (ELD) rule, which is congressionally mandated as a part of MAP-21, is intended to help create a safer work environment for drivers, and make it easier and faster to accurately track, manage, and share records of duty status (RoDS) data.* ELD captures engine run-time and translates that into operator driving time to determine the accurate hours of service (HoS).

Phase 1: ELD or AOBRD Compliance

December 18, 2017 – December 16, 2019

Phase 2: ELD Compliance

December 16, 2019

The government mandate demands that all vehicles and drivers subject to Record of Duty Status (RoDS) must have an ELD solution.
